Present General Terms of Use (hereinafter: “Terms of Use”) determine the conditions of using the [www.goquick.hu](http://www.goquick.hu) website (hereinafter: the “Website”) exclusively owned by Go Quick & AVS Skills Development Limited Liability Company (9027 Győr, Nagysándor József Street 31., Cg. 08-09-024119, hereinafter: „GoQuick Ltd”) and operated by GoQuick Ltd. Every mature natural or legal person or unincorporated entity and other organisation is considered a user, who registers on the Website and creates their own account/identity (hereinafter: the “User”). Minors shall not use the Website. By registering on the Website, or using any provided service, or subscribing for newsletter, the User expressly agrees to comply with present General Terms of Use. The acceptance of these terms also means that the User agrees to follow up changes in present General Terms of Use. In case the User does not accept present General Terms of Use, they are not entitled to use the Website, or any of the provided services.

The owner of the Website reserves the right to modify present General Terms of Use unilaterally any time. In case any modification takes place, the owner is obliged – according to concerning legislation - to indicate it prior to the modification should come into effect, on clearly visible part of the Website, to inform the Users in due time. Additionally, formerly registered Users are provided to terminate their registration if they do not wish to accept the amendments of the terms of use. The modified Terms of Use come into effect on the day they are posted on the Website. GoQuick Ltd. calls the attention to the modifications for 7 days after they have taken place.

## Conditions of using the website

By accepting present Terms of Use, the visitor of the website (hereinafter: “Visitor”) declares to

- be an adult, or if not, use the website with the permission of the parents or guardian;
- act solely on his own behalf and does not use other people’s data;
- have accepted present Terms of Use, have understood and acknowledged its content and decides upon further usage in the light of all these;
- set the browser in accordance with the disallowance of cookie usage – in case of such decision – or delete the already placed cookies from the computer and avoid using the website in the future. (To learn more about cookies, see the Information collected automatically chapter.)

- GoQuick Ltd. declares to
- have acted as the data manager concerning the data stored on the website;
- not store, not disclose and not collect any sensitive data, i.e. anything in connection with the Visitor's race, ethnic origin, political opinions, religious or philosophical beliefs, health status, or sexual life;
- not store, not disclose and not collect any adult content.

## Operating principle of the website

GoQuick Ltd reserves the right to change, or even terminate any part of the website anytime.

GoQuick Ltd operates the website as an intermediary provider in accordance with the following legislative provisions

- CXII 2011. Act about the right to self-determination and freedom of information
- XLVIII 2008. Act about the essential aspects of business advertising and certain limits
- XLVII 2008. Act about prohibiting unfair trade practices against consumers
- Act C of 2003 on Electronic Communications
- CVIII 2001. Law on Electronic Commerce, as well as some of the issues of the information society
- 1997 CLV. Law on Consumer Protection
- LVII of 1996. Law about prohibition of Unfair and Restrictive Market Practices
- CXIX 1995 Act about name and address data management for the purpose of direct marketing.

## Registration and use of website

GoQuick Ltd and its Partners may use the users' data only in connection with the provided service. For other purposes, these data may only be used with preliminary determination of target and on the basis of the User's contribution.

### Registration

Services of the Website can only be used after preliminary registration. During the registration, it is compulsory to provide the following data:

- surname
- first name
- e-mail address
- password
- date of birth
- zip code number

By clicking on "Registration", the User will receive a confirmation email at the provided email address after entering the necessary personal data (surname, first name, etc.) and an operating, real email address. In this confirmation email the User can finalise the registration by clicking on the provided link and entering their confirmed password. After this, users are immediately entitled to use basic services of the Website.

With any kind of registration, the user authorises the owner of the Website to send notifications about activities defined in the Privacy Policy (e.g.: newsletters in connection with the Website, commercial communication) to the user's provided email address. At the same time, the user commits to inform GoQuick Ltd. and/or their Partner through an appropriate communication channel provided in the Privacy Policy (web interface, e-mail, telephone, fax, in person, etc.), if any change may occur in the data provided at the time of registration.

### Using the website

During the use of Website, the User should act in accordance with the requirements of good faith and integrity, maintaining the obligation for cooperation, in accordance with the principle of legal practice, respecting the concerning legislative provisions. Consequently, the site cannot be used for improper or prohibited distribution of offensive content, applications, computer viruses, unlawful data collection, anything that offends the usually accepted and applied customs in the information technology industry (Netiquette - Online Code of Conduct).

The User is explicitly responsible to GoQuick Ltd for any damage or loss suffered by GoQuick Ltd that has been caused by improper or prohibited use of the Website on the User's side. GoQuick Ltd.

Without the prior written permission of GoQuick Ltd the User is not entitled use the Website for advertising or other promotional purposes, use for political purposes is strictly prohibited. The User authorises GoQuick Ltd to use the contents uploaded by the User to the Website, including their editing, conversion, copy and distribution.

In case GoQuick Ltd learns about any improper or prohibited use of the Website on the User's side, they are entitled to suspend the User's registration.

User acknowledges that habits in connection with using the Website can be collected for statistical purposes on condition that the user's person cannot be identified. The User also acknowledges that GoQuick Ltd will monitor and moderate interactive micro-sites, forums, chat rooms that are potentially available on the Website. User acknowledges that in case of prohibited use of these micro-sites, GoQuick Ltd is entitled to suspend the User's registration. The lawful and fair use complies with the following requirements:

- Use the Website at your own risk.
- GoQuick Ltd does not take responsibility for the authenticity, content, completeness, legality, reliability of any comment uploaded or published by the User, nor for business or other decisions based on these posts and their consequences; no compensation, reimbursement or any claim can be sustained on this basis. Please note, that we monitor every comment appearing on the Website and delete them if necessary, particularly if the User's comment violates the rights of others, invites for defamatory, infringing, or similar activities, if it has defamatory, disturbing or offensive content, if it is misleading or misrepresenting in the disclosure of real facts, if it is inappropriate, or considered as advertisement, or if it contains programs that jeopardize the proper functioning of the information system. These comments and shared contents are deleted and in case of multiple appearances the user – without any prior notification – will be banned from the site.
- GoQuick Ltd does not take responsibility for any loss, damage, or expenses deriving from delayed transmission, unauthorized modification of information and data by unauthorized persons, operating disruptions, malfunctions, circuit-, and system failures on the Website.
- Some links on the site may lead to the site of a third person. GoQuick Ltd does not take responsibility for the content and authenticity, security and privacy of information on these sites.
- All images and texts on the Website and their display and layout are protected by trademark and under copyright; only sharing the data content – without making any changes is allowed. Beyond this, using the data content in any form – exceeding the amount of personal use – especially the copy, distribution and modification is prohibited and legally disciplinable.

The User may change the password to their account any time, but it should be kept in secret and the User should take necessary and reasonable precautions in order to prevent unauthorized persons from accessing to the User's account.

GoQuick Ltd notifies the Partner of withdrawal of access permissions without delay after receipt of notice. In case a third person abuses the improperly obtained information prior to notifying the Partner, GoQuick Ltd does not take responsibility for the caused damages.

## Intellectual Property

Every content, description, graphics and chart on the Website and the Website itself is the exclusive property of GoQuick Ltd or their Partners if appropriate. The Website is considered a collective work in accordance with LXXVI. 1999. Act 7. § about copyright and as such, is subject to copyright protection.

It is not allowed to make copies in any form of the contents on the Website, it is not permitted to record them neither analogically nor digitally, they cannot be reproduced, distributed, transmitted, downloaded, edited, resold or publicly disclosed. Any content of the Website can only be used for commercial or other purposes with the prior written consent GoQuick Ltd. Using the GoQuick logo and other copyright contents is only permitted with the prior written consent GoQuick Ltd. Logos and other content that appear on the website within the exclusive rights of the Partner may only be used with the Partner's written consent.

Any violation to GoQuick Ltd intellectual property (trademark infringement, copyright infringement) will entail the offender's impeachment.

## Limitation of liability

GoQuick Ltd deals with the sales of e-commerce mediated services, however it is not responsible for the quality of services provided by its Partners. In case the User should suffer any harm during the use of these services GoQuick Ltd will exclude any liability and the User can only claim for the damages from the Partner.

GoQuick Ltd does not take responsibility for the continuous, successful virus and parasites free operation of the Website and the related websites. GoQuick Ltd is not liable for the User's potentially lost online data during use of Website. The User is responsible for the appropriate condition of their software and hardware devices and also for their capability to use the Website, to up-, and download different contents on the Internet.

## Automatically collected information

During the visits to the Website, one or more cookies – i.e. small files containing a string of characters – are sent to the Visitor's computer to enable the identification of his browser for a while. The cookie is a personal datum, its purpose is to identify the users, distinguish them from each other, to store data during the session and to avoid data loss in case of session interruption. The user's (as concerned) contribution is the legal basis of the data management. These data are: he generated code, and date and time of the operation.

According to their functions, cookies can be:

cookies that make liking and sharing possible;

- cookies with basic importance, storing the data of the transaction in progress, thus essential;
- cookies that support the Website's operation, store the login data, support chat service;
- cookies that support display, help in providing the Website's unified image;
- cookies that increase the efficiency, decrease loading time, increase user experience.
- Cookies used by the homepage:
- YouTube cookie: Support playing videos. 1 year expiry.
- DoubleClick cookie: Google remarketing cookie. 1 and 2 years expiry.

External service providers store the visitors' possible previous visits on the advertiser's website and display advertisements for the visitor on external service partners' websites. External service providers display advertisements on the basis of the visitor's previous visits on the Website with the help of these cookies.

By accepting present Terms of Use the Visitor acknowledges and allows

Google Analytics functions based on visual advertisements on the Website (e.g. remarketing, Google Display network visualization reports, or Google Analytics interests and demographic reports);

- we interlace personally identifiable information with non-personally identifiable previously collected with data DoubleClick cookie-based visual advertisement function;
- the Website uses remarketing functions of Google Analytics for online advertisements;
- our advertisements are displayed by external service providers as well, like Google, on their websites;
- the Website and external service providers (e.g. Google) use their own cookies (e.g. Google Analytics cookies) and cookies of a third party (e.g. DoubleClick cookie) for the orientation on the basis of previous visits to the Website, for the display and optimisation of advertisements and to determine how the ways of advertisement displays, other uses of advertisement services, interactions with advertisement display and advertisement services are related to the visits on the Website;
- the owner of the Website uses Google's interest-based advertising information and audience data from third parties (e.g. age, gender, fields of interest) with the Google Analytics service.

## Data management

The confidential management of the User's personal data is a prime requirement. GoQuick Ltd may only transmit these to external organisations which are included in the Privacy Policy. The User's personal data may only be available for the authorities in accordance with concerning legislation.

GoQuick Ltd will only use those data that are necessary for the User's identification in order to send them information about the development of mediated services, about the regularly increasing range of offers and about official notices of GoQuick Ltd.

The User's registered data and the information in the GoQuick Ltd data base can be used to solve arising matters and disputes between GoQuick Ltd and the User, or between the User and a Partner. The User can change the provided data after the registration. In this case, however, the formerly provided data will be stored in GoQuick Ltd data base until the expiry of user privileges.

## Applicable law

Present Terms of Use is governed by the Hungarian law. In case any of the provisions in present Terms of Use would prove to be invalid, it shall not concern the validity of the other provisions. Instead of the invalid provision, a provision of adequate legislation comes into effect automatically.
